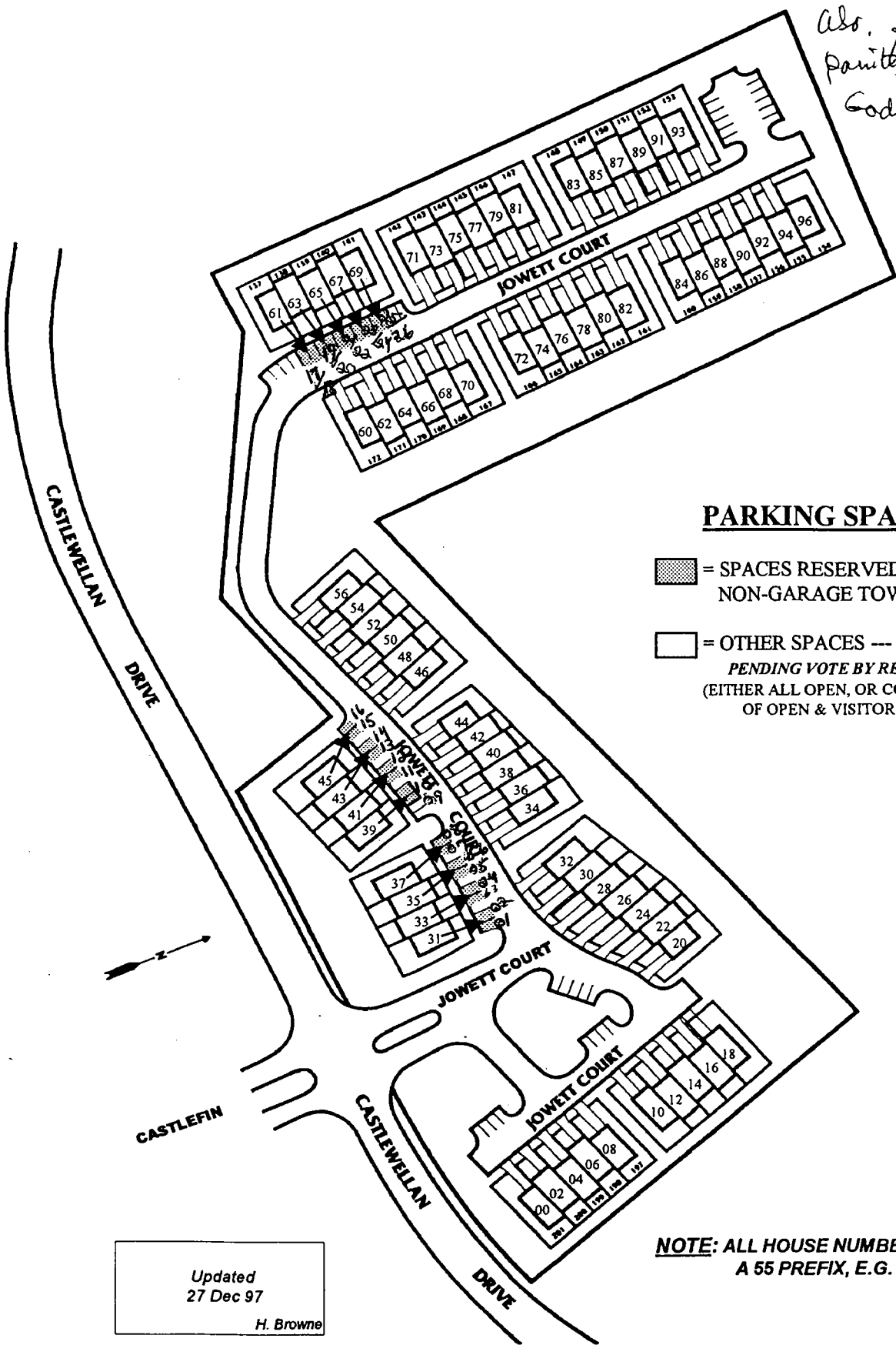

RE: Reserved Parking Plan

The KROC Board of Trustees gave preliminary approval to a reserved parking space assignment plan in Coventry. The reserved parking space assignment plan, includes a listing of the two numbered parking spaces which have been assigned to each nongaraged townhouse unit. Numbers will be painted with in the next two weeks as weather permits.

THE FOLLOWING ARE IMPORTANT DATES TO KEEP IN MIND ---

Notice Period: KROC Parking Policies stipulate a 30-day Notice Period. Such Notice Period will commence with the date of this memo, and will end on March 6. During this Notice Period, residents are encouraged to park in their assigned parking spaces only.

Trial Period: In conformance with past practice, a trial period of 60 days will commence on March 7. During this 60-day Trial Period, Coventry residents are expected to park in their assigned parking spaces only, but towing of unauthorized vehicles from assigned spaces is NOT permitted.

Also in conformance with past practice in Kingstowne, the Trial Period culminates with the KROC's Board's review of the apparent success of Coventry parking space assignment plan as revealed during the Trial Period, and with KROC's Board's final approval of the plan. As this sequence of dates sets out against the calendar, the KROC Board would anticipate a review of Coventry's parking plan in light of the Trial Period experience at the Board's June regular meeting.

All parking spaces which are unassigned will be available on a first-come, first served basis.

Please review and become familiar with "Resolution No. 12 Vehicles Policies" for Enforcement Procedures in your Kingstowne Handbook. Once Coventry's parking space assignment plan has received final approval by the KROC Board, residents have the right to tow an unauthorized vehicle from their assigned space only, the KROC Business Office should be contacted regarding towing of vehicles in visitor spaces. If towing is required residents are obligated to use KROC's authorized towing agent: Springfield Towing, 7901 Cinderbed Road, Newington, VA 22122, telephone number (703) 971-9262. Management will be posting signs at the entrance to Coventry stating "Numbered Parking Spaces Reserved, Towing by Springfield Towing 971-9262.
